Cancelations need to be sent to Paige by Sunday before the week begins. After Sunday, we will bill cancelations as a regular scheduled service.

**PAYMENT:** Billing statements are emailed on the last day of the month and are due no later than the 5th of the following month. Late payment charges of \$5/day will begin to accrue on the 6th. Prices subject to change - We accept: Credit cards, Cash, PayPal, GoogleCash & Venmo.

**In consideration of the following terms and conditions and other good and valuable consideration hereby acknowledged by the parties hereto, Client and Sincerely Pets agree as follows:**

In the event of an emergency (e.g., injured pets, severe weather, broken pipes, natural disaster, fire, etc.), Sincerely Pets is hereby authorized to take all measures deemed necessary in its sole and absolute discretion in caring for Pets and Client's property (including without limitation emergency veterinary care for Pets and emergency repair services for Client's home) and Client agrees to defend, indemnify and hold harmless Sincerely Pets, its respective employees, members, agents and affiliates from all liabilities, claims and expenses, including reasonable attorneys fees, that arise from or relate to such decisions. In the event of such an emergency, Client shall immediately reimburse Sincerely Pets for expenses incurred, plus any additional fees or expenses for attending to such an emergency. Furthermore, Client is responsible for providing keys to access their home or building. Any locksmith fees incurred as a result of providing faulty keys is the financial responsibility of the Client.

IN CONSIDERATION OF THE SERVICES AND AS AN EXPRESS CONDITION THEREOF, THE CLIENT EXPRESSLY WAIVES AND RELINQUISHES ANY AND ALL CLAIMS AND LIABILITIES OF ANY KIND AGAINST SINCERELY PETS ARISING FROM OR RELATING TO THE SERVICES OR THIS AGREEMENT, EXCEPT THOSE ARISING FROM THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF SINCERELY PETS. WITHOUT LIMITING THE FOREGOING, IN NO EVENT SHALL SINCERELY PETS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES OF ANY KIND IN CONNECTION WITH THIS AGREEMENT, EVEN IF SINCERELY PETS HAS BEEN INFORMED IN ADVANCE OF THE POSSIBILITY OF SUCH DAMAGES; IN NO EVENT SHALL SINCERELY PETS TOTAL AND AGGREGATE LIABILITY HEREUNDER EXCEED THE AMOUNT PAID BY CLIENT TO SINCERELY PETS HEREUNDER.
